Leisha Rospert reported that we are still in need of a Program Chair. Leisha notified all attendees of the vacant position and invited all to reach out to her if they were interested in becoming Program Chair.

Leisha Rospert confirmed the dates for the 2022 meetings

February 18, 2022 May 20, 2022 July 15, 2022 September 16, 2022 Leisha Rospert- launched a survey monkey survey in the fall the results relayed that 77% will meet attend remote meeting, 8% said no they would not.

The survey question and answers received:

What topics would you most like to learn about or discuss at our meetings?

- Rapid changes to the work environment and strategies to help firms address them. Remote work,
- Flexibility, mental health and well-being of their teams, impact of technology, new pandemic related programs and how best to manage them, etc.

- Impacts on metrics (I.E. were expectations lessened b/c of WFH, are you keeping metrics lower moving forward, have you removed hours expectations, etc.)
- CPE and training resources -does anyone have a "trainer" or dedicated resource?
- Licensing -is anyone using software or outsourcing the process?
- Data analytics -has anyone hired for a PM or other "non-traditional" CPA roles?
- Topics could include how to manage resources i.e. scheduling; how to on board team members; how to onboard clients. Also, like hearing about software applications: knowledge base software, practice management software, people development/training, prospects/new clients.
- Talent management.
- Remote work and firm culture.
- If wages have changed across the firm, from receptionist to management/partner, and if anyone is willing to share an updated wage range. Do firms have internal or external HR/onboarding/payroll, etc. Have any firms experienced situations where accountants, CPA's cannot work together, and if so, how that was resolved and is there policy outlining such matters.
- Leadership/Coaching-Action coach or other speakers on leadership/culture, etc.
- Current status of workplace re-entry. OSCPA can enhance our relationship with your firms and CPAFMA and increase experience and engagement with you.
- OSCPA can assist with speakers.
- Staffing, what kind of insurance benefits are firms offering and what is the level of cost coverage.

Leisha Rospert reminded all that the 2022 CPAFMA Practice Management Conference will be held solo for 2022 in Portland, Maine from June 21-24, 2022. Rita Keller commented she had attended a previous meeting in Portland, Maine and it was a great area to hold conference.
