From Baton Rouge: Take the Williams Blvd exit from I-10, Turn right onto Williams Blvd and get in the far left lane as soon as you cross the canal. Turn left at the light onto Veterans Memorial Blvd and stay in the left lane. The Xerox Centre will be on your left. It is a 5-story black glass building. You will need to take the U-turn and return westbound on Veterans Memorial Blvd. The entrance to the Xerox Centre leads to the parking area located at the rear of the building. Do not park in assigned spaces. From New Orleans: Take the Power Blvd, exit from I=10 Turn left onto Power Blvd and cross over the Interstate. Turn right at the light onto Veterans Memorial Blvd. The Xerox Centre will be on your right, approximately 1.5 miles from Power Blvd. It is a 5-story black glass building. The entrance to the Xerox Centre leads to the parking area located at the rear of the building. Do not park in assigned spaces.
